






#### Radiation Characteristics <sup>1)</sup>







## Forward Voltage <sup>1) 2)</sup>




### **Optical Output Power** <sup>1) 2)</sup>



#### **Relative Forward Voltage 1)**




#### **Relative Radiant Power**<sup>1)</sup>




